I BOTOX TRAINING MODULE: Applied Theory of Botox didactic material providing the necessary knowledge of the substance, its indications and contraindications, side effects, dilution and injection methods, and review of the pertinent anatomy. Live patient injections will be done by the doctor taking the course.

Lunch break (30 minutes) - lunch will be provided

II FILLER TRAINING MODULE: Filler types will be discussed, injection sites and techniques will be reviewed, pertinent anatomy will be taught. Live patient injections will be done by the doctor taking the course under the supervision of Dr. Naslenas.

By the end of the program the participants will be provided with all the pertinent patient letters, insurance forms, and all the information on how to place orders from Allergan, Merz, and sundries' companies, as well as the required insurance forms. First day back at your own office the participants will be able to:

- Understand the indications and contraindication for this treatments and techniques
- Perform an efficient comprehensive patient evaluation for best therapeutic outcome
- Locate the ideal anatomical sites and injection depths as they relate to the pericranial anatomy of the head and neck
- Understand the physiology and pharmacology of the Botulinum toxin
- Understand the risks and side-effects of Botulin toxin
- Combine Botulinum neurotoxin therapy with dental therapeutic and esthetic treatment plans
- Understand Botulinum therapeutic treatment of migraines, TMD, facial pain and parafunctional clenching cases
- Learn the appropriate dilutions for the different anatomical structures
- Prevent and treat adverse reactions
- Experience live patient hands-on training including diagnosis, treatment planning, dosing and delivery of neurotoxin
- Complete proper patient documentation and informed consent
- accelerate orthodontics and implant integration by controlling clenching
- Assess lip anatomy and inject for improved facial balance
